Additional Information	Students will be supported to build skills in team working and collaboration. Students will also be assisted to improve their professional written and spoken communication. In addition, the module aims to promote critical awareness of the social and cognitive processes underlying witness testimony, investigative interviewing, lie detection, confessions, and identification parades. Students will develop a critical understanding of the reliability of these pieces of evidence and how the psychological processes associated with different types of biases can help to prevent judicial error. Finally, this module addresses how psychological assessment can be a valuable tool when working in these contexts.
