Aims and Outcomes

Aims This CPD module will raise the student's awareness of the significant benefits in utilising the various aspects of financial investigation to effectively deal with all levels of criminality, including serious and organised crime. The programme will initially evaluate the strategic approaches, current legislation and assess the relationship between financial investigation, proceeds of crime and asset recovery. It will take the student through a systematic and structured approach in considering the offences, powers and investigation processes involv also assessing those same issues in relation to money laundering. The Module will evaluate the role of the Financial Investigator and Financial Investigation Teams from the local, regional, national and international perspective, together with measuring the benefits, efficiency and effectiveness of the multi-agency approach to financial investigation, the re-u of assets, how performance is measured and the judicial processes.NOTE - This module is only available for the closed client group of officers and staff employed by law enforcement agencies who have the current level of vetting, as required by their respective employer, to deployed in this area of investigation.
