Aims and Outcomes

Aims	This programme will assess the 4 x P approach within the Government's Serious and Organised Crime Strategy, initially focussing on the Prevent element and evaluating the effectiveness of the multi-agency and partnership approach to that aspect of the policy.Students will consider 'County Lines' and the associated criminal exploitation of children and vulnerable people, before assessing the multi-agency approach to dealing with assessment of the threat, harm and risk relating to serious and organised crime. The module will then examine the local, regional and national processes that determine the areas of ownership and responsibility. Students will evaluate the tasking and allocation processes, examining the benefits, risks and comparison of the partnership approach between disruption and investigation, the programme will also critically assess the performance measures that are currently in place.
