Aims and Outcomes

Aims	This programme will critically examine the issues involved in honour based abuse, taking the student through a structured and methodical approach in considering the varying legal status of foreign nationals within the UK and discuss issues including forced and arranged marriages, female genital mutilation and so-called honour based violence. Students will study the various forms that honour based abuse can take, the religious and cultural issues involved, the governing legislation, how these cases are considered and dealt with in the UK and what motivates offenders. The module will also consider the agencies involved in dealing with cases of honour based abuse in the UK, evaluating their respective role and responsibilities and how these agencies work together in addressing all aspects of such cases.

Additional Information	<p>Programme code: 36234 There are no professional body requirements at present.</p> <p>Developments of the College of Policing are constantly monitored and incorporated, where appropriate.</p> <p>Benchmark Statement: There are no subject benchmarks for police studies but cognisance has been taken of the evolving police professionalisation agenda and where applicable the requirements of the College of Policing, together with appropriate National Occupational Standards for policing set out by Skills for Justice, the Benchmark Statements for Criminology and other QAA Benchmark Statements when appropriate.</p> <p>Mode and Duration of Study: This CPD module will be offered on a part time basis and through delivery on-site (at LJMU), off-site or through a blended delivery process incorporating some distance learning where necessary. The university's Virtual Learning Environment, Canvas, will be utilised to support the delivery of this programme. This programme will be available from March 2019 and whilst the intake month is flexible, it is possible to commence the programme in semester 1, semester 2 or during the summer period. The duration of study will usually be across 18 weeks.</p> <p>Criteria for Admission: The entry requirement is a first degree at 2:2 or above, international equivalent. This CPD module is open to recruitment for Police Officers or Police Staff. The content of the programme is also of relevance to individuals working in other law enforcement agencies who will deal with any aspect of Honour Based Abuse as a key element of their work processes (e.g. the NCA, UKBA or DWP).</p> <p>Name of Final Award: Certificate of Professional Development - Honour Based Abuse.</p> <p>Student Support: The University aims to provide students with access to appropriate and timely information, support and guidance to ensure that they are able to benefit fully from their time at LJMU.
