Outline Syllabus

Issues covered:
1)History and development;
2)Institutional interaction – related to integration theories;

5)Democratic deficit, demos theory and accountability – is the individual's voice adequately heard?
6)Is it a Union with a definite social conscience/policy, or still an intergovernmentalist club masquerading as a democratic entity?

Learning Activities

The course will utilise a blend of standard lecture methods together with interactive and self-directed, independent learning and research: sessions will be split between lectures and workshops.

Where appropriate, lecture materials (handouts/slides etc) will be provided both in paper form and electronically, with the added possibility that online platforms may be used to deliver content (online workshops, twitter, discussion boards etc.,).

Students will be expected to engage with the rest of the cohort in workshop/seminar sessions, as well as being expected to undertake preliminary reading prior to each session.
