Outline Syllabus

This module will provide a broad critical perspective of the relationship between policy and practice in the current context of the Lifelong Learning Sector. The influence of major social, political and economic factors on the changing context of Lifelong Learning will be considered. The nature and impact of policy and legislation will be addressed and a particular emphasis will be given to new, current policy initiatives.

Learning Activities

Individual tutorials and small group seminars supporting individual research and group presentation. Action learning sets to encourage collaborative and autonomous learning.
