Outline Syllabus

Contrasting traditions: positivism versus social constructionism. Broadening the philosophical debate: ontology and epistemology; epistemology and methodology. Research philosophies underlying research practice: positivist research; realist research; social constructionist research. Overview of other philosophies: critical theory; feminism; hermeneutics; postmodernism; pragmatism and structuration theory. Strengths and weaknesses of different epistemologies.

Learning Activities

A blended learning approach will be used with a mix of formal lectures, guest lectures, tutorial sessions, student-led sessions, individual and group activities, directed study and Peer Learning Group. Learning activities will be centred on 4 block sessions, the first of which will orientate the students to the module's learning activities.
