Outline Syllabus

This module centres on a critical examination of current issues in education from the perspective of the critical, reflective professional. A major current issue is identified as the case study for critical examination of the nature of policy and policy implementation on professional practice. Different policy implementation frameworks are presented and examined critically as the content focus. Students will work individually (with a range of learning supports) to present a formal critique of the policy-led issue and its impact on practice in the form of a conference paper.

Learning Activities

Induction and introduction module, content and processes, critical outline of the identified issue. Individual tutorials and staged seminars supporting individual projects. This will develop skills of reflection, criticsm and develop a sense of a community of educational critical and reflective practitioners. In order to achieve this the module leader will lead a number of interactive seminars to review progress in the form of seminar presentations. Students will also engage with and be supported through the use of interactive technologies such as discussion boards via Blackboard. Final papers will be presented at school based conference events.

Notes

This module provides a flexible but supportive framework for students wishing to

investigate and respond to an issue of current imprtance in educaion identified by the programme team. Students will be supported and equipped with the requisite knowledge and skills to complete a format critique of the issue. trhe module also provides an importent opportunity for professionals working at masters level of experiencing the production of a mini conference paper and sharing theior findings with fellow professionals as part of a university led community of practice. A mini conference will be held after the module where student conference papers will be presented.
