Aims	Building on the Medical Negligence module which concentrated on substantive legal issues, this module attempts to place the fault based system for compensating victims of medical accidents in the broader context of disciplinary processes, complaints systems and other quality assurance processes more generally and the regulation of medical practice as a whole. It will also compare and contrast alternative dispute resolution mechanisms and no fault compensation systems. Comparative dimensions will be infused throughout.
